Public Comment period was waived.

Motion by Hadley, second by Johnson to approve the amendment/update to the City COVID19 response policy. Roll call vote. All voting aye. Motion carried.

This being the date and time for a public hearing on the plans, specifications, form of contract, estimated total cost and accepting bids for the 2020 Quarry Street Storm Sewer Improvement Project the hearing was opened.

No public comment. The hearing was closed.

Motion by Luse, second by Hadley, to approve Resolution 3061 approving the plans, specifications, form of contract and accepting the Skyline Construction bid of \$437,717.50. Roll call vote. All voting aye. Motion carried.

Ordinance 1244 establishing the Decorah Sustainability Commission was introduced and read for the second time. Motion by Luse, second by Bergan, to approve the second reading. Roll call vote. Voting aye: Luse, Hadley, Neal, Carlson, Johnson, Bergan. Voting nay: Schissel. Motion carried.

Motion by Luse, second by Neal, to waive the third and final reading and place the ordinance on its' final adoption. Roll call vote. Voting aye: Luse, Neal, Bergan, Johnson, Carlson, Hadley. Voting nay: Schissel. Motion carried

Ordinance 1242 increasing water rates by 2% was introduced and read for the second time. Motion by Bergan, second by Carlson, to approve the second reading. Roll call vote. All voting aye. Motion carried.

Motion by Schissel, second by Carlson, to waive the third and final reading and place the ordinance on its' final adoption. Roll call vote. All voting aye. Motion carried.

Ordinance 1243 increasing sewer rates by 2% was introduced and read for the second time. Motion by Luse, second by Neal, to approve the second reading. Roll call vote. All voting aye. Motion carried.

Motion by Schissel, second by Carlson, to waive the third and final reading and place the ordinance on its' final adoption. Roll call vote. All voting aye. Motion carried.

Consideration of Resolution 3063 supporting National Legislation to enact a carbon fee and dividend program to reduce polluting and climate-changing carbon emissions and declaring an emergency was opened for discussion.

Councilperson Schissel stated his belief this is just a wealth distribution plan. It will adversely affect the low to moderate income demographic in the short term.

Lyle Otte stated it will help those in that income bracket more than the wealthy.

Councilperson Luse stated he will not vote for this unless language is added to eliminate subsidies to the fossil fuel industry.

Councilpersons Neal, Hadley and Johnson all said this is different and the two shouldn't be linked together.

Motion by Johnson, second by Neal to approve Resolution 3063 supporting National Legislation to enact a carbon fee and dividend program to reduce polluting and climate-changing carbon emissions; and declaring an emergency. Roll call vote. Voting aye: Johnson, Neal, Hadley, Carlson, Bergan. Voting nay: Luse, Schissel. Motion carried.
